



## Skating Club of Southern New Jersey 2010—2011 Membership

The club, through membership in the USFS, encourages figure skating skills and knowledge through a series of tests to measure the accomplishments of the skater in the four areas of figure skating. These are moves in the field, free skating, pair skating and ice dancing. Skaters must be members of the USFSA before they can be tested. This system is used as a base for skaters to qualify for the various levels of competition.

#### Instructions:

Complete the membership application and submit to SCOSNJ:

1. SCOSNJ membership application (renewal or new membership) must be completely filled in. The form may be duplicated for additional skaters.
2. The **membership application and "Important Information" form**, must contain a valid signature. If skater is under the age of 18, a parent/guardian must sign.
3. New applicants to the SCOSNJ require a club member to sponsor them and approval of the board. If membership is denied, all submitted fees will be refunded.
